STA Mirabegron for the treatment of symptoms associated with overactive bladder

The impact on equality has been assessed during this appraisal according to the principles of the NICE equality scheme.

Consultation

Yes. The only equality issue identified during the scoping process was people with overactive bladder whose symptoms have not been controlled with currently available therapies may need to supply their own incontinence pads. For low-income patients, these out-of-pocket expenses represent a higher proportion of their total income. The Committee noted that this was not a group protected under equalities legislation, and that the use of mirabegron would be unlikely to affect this group disproportionately.

No other equalities issues have been raised.
