#### Consideration of consultation responses on review proposal

#### Review of TA47 Glycoprotein Ilb/Illa inhibitors in the treatment of acute coronary syndromes

This guidance was issued in September, 2002.

The review date for this guidance: A review of glycoproteins was considered during July 2007. It was decided (after consultation) that the existing guidance should be updated by the NICE clinical guideline on acute coronary syndromes. However, only part of the current guidance will be updated by the clinical guideline (sections 1.1 - 1.6). This review covers sections 1.7 and 1.8 of the guidance.

#### Background

At the GE meeting 23 March 2010 it was agreed we would consult on the review plans for this guidance. A four week consultation has been conducted with consultees and commentators and the responses are presented below.
