NICE is unable to make a recommendation about the use in the NHS of ibrutinib with rituximab for treating Waldenstrom's macroglobulinaemia in adults. This is because Janssen did not provide an evidence submission. They consider that there is not enough evidence to provide an evidence submission for this appraisal.
