<b>1. Welcome and introductions</b>	<p>The Chair welcomed everyone to the tenth Local Government Reference Group (LGRG) meeting.</p> <p>The Chair informed the group that apologies had been received from Dave Burnham, Dominic Harrison, John Illingworth, Jonathan McShane and Derek Ward.</p> <p>The Chair welcomed the observer Jonathan Tross (a Non-Executive member of the NICE Board) to the meeting.</p> <p>The Chair noted that a member of the public was expected to attend however they had not arrived.</p> <p>The Chair informed the group that Carolyn Rule has resigned from the LGRG. The Chair formally thanked and recognised Carolyn for her valuable contribution to the group.</p>	
<b>2. <b>3. Return on Investment</b> <ul style="list-style-type: none"> <li>Consideration of the draft document (effectiveness/ cost effectiveness/ epidemiology/ return on investment/ key audiences and local data)</li> </ul>	<p>Lesley Owen (LO) and Sue Jelley joined the meeting via VC at 10.15am. The Chair introduced the briefing and noted that this was the fourth time that the LGRG had viewed it.</p> <p>LO presented the amended version of the Return on Investment briefing paper.</p> <p>A broad ranging discussion ensued which included a suggestion to develop, perhaps 18 months to 2 years hence, a briefing which reflects PH analyses from the perspective of local government and also the political nature of local government (re: elections every 4 years)</p>	

<ul style="list-style-type: none"> <li>Recommendations for amendments</li> </ul>	<p>unlike the NHS). The current document is still considered too NHS facing, but LGRG members haven't as yet provided costing and value for money examples from local government. The LGRG agreed that the details concerning economic methods should be provided elsewhere (and hyperlinked) and that the focus of the current briefing should be on the cost effectiveness of PH interventions. In addition it should retain something about NICE's methods evolving to better capture the multiple community impacts of PH interventions.</p> <p><b>Action: LO to take the suggested amendment of adding other outcomes measures such as DALYs back to Mike Kelly</b></p> <p>The Chair noted that these briefings will be reviewed for update in two years' time.</p> <p>Dagmar Zeuner arrived at 10.40am and had no further interests to declare.</p> <p>SJ gave an editor's opinion on the layout of the briefing.</p>	<p>LO</p>
<p><b>4. Return on Investment</b></p> <ul style="list-style-type: none"> <li>Summary of the discussions, agreed actions</li> </ul>	<p>The LGRG suggested that the briefing was not yet fit for purpose. It was suggested that the detail should be rewritten and the tone amended with the local government audience in mind. It was suggested that the briefing should focus on local, political and community issues. There was a discussion around best value principles.</p> <p>Ruaraidh Hill (RH) arrived at 10.45am.</p> <p><b>Action: The LGRG to send any examples of cost savings to the NICE Team.</b></p> <p><b>Action: LO to create a separate document to run alongside the briefing and the infographic and will email these amended documents to the LGRG for further final comment prior to publication.</b></p> <p><b>Action: The LGRG to send comments to the NICE team by the suggested deadline.</b></p> <p>The LGRG thanked LO for all of her work on what they believed would be an exciting and useful briefing.</p> <p>LO and SJ left the meeting at 11.10am.</p>	<p>LGRG</p> <p>LO</p> <p>LGRG/NICE Team</p>

These included: adding information from the Marmont review; adding reference to looked after children, bullying, risky behaviours, nutrition and work in the community; and addressing repetitive content. It was noted that these amendments would broaden the relevant audience for this briefing.</p> <p><b>Action: RH to look at adding a link to the briefing from the mental health foundation website.</b></p>	<p><b>RH</b></p>

Social and Emotional Wellbeing in Children and Young People</b></p> <ul style="list-style-type: none"> <li>• Summary of the discussions, agreed actions</li> </ul>	<p>The Chair gave a summary of the discussions and returned to the comments from the road testing. There had been a lack of awareness in the road testing around the NICE guidance and briefings and this was noted as a concern. There was a discussion around how NICE is currently connecting with the field.</p> <p>RH left the meeting at 11.45am.</p>	
<p><b>7. Preventing and controlling TB among vulnerable groups</b></p> <ul style="list-style-type: none"> <li>• Feedback from road testing, DH and PHE</li> <li>• Final viewing by LGRG</li> </ul>	<p>Catherine Swann (CS) joined the meeting via VC at 12pm.</p> <p>CS presented the changes on the briefing on Preventing and controlling TB among vulnerable groups. CS gave feedback from the “road testing” that took place in Oldham, as well as feedback from the DH policy leads and Public Health England. CS informed the LGRG that this briefing will have a joint badge with PHE.</p> <p>The LGRG considered the draft document and a number of recommendations for amendment were made. These included mentioning the local departments of public health within the briefing; partnering with the Association of Directors of Public Health; including local authorities and their role around housing stock and including care of the vulnerable.</p> <p><b>Action: The DPH members of the LGRG to comment on how best to implement the above.</b></p> <p><b>Action: CS to check that the briefing is using the correct wording from the guidance, particularly around the use of public health resources.</b></p> <p>It was noted that NICE’s role is to deliver information on effectiveness and not to specify what funds should be spent on, unless there is strong scientific evidence to recommend this.</p>	<p><b>LGRG</b></p> <p><b>CS</b></p>

<p><b>9. Discussion around “Hard to Reach Groups”.</b></p>	<p>Kay Nolan (KN) joined the meeting at 11.40am and asked the LGRG what they understood by the term “hard to reach groups”. It was agreed that this had little real meaning and was not a term that should be used regularly.</p> <p>KN noted that NICE’s understanding of this term was to improve access to health services for individuals, families and communities who are disadvantaged, excluded, marginalised or vulnerable.</p> <p>It was suggested the briefing should provide an evidence base on a range of different approaches that improve access to services. It was also suggested it should be inclusive of health and social services.</p> <p>The Chair asked the LGRG what the title of this briefing would be and “Vulnerable or Priority Groups” was suggested.</p> <p>The challenges with the writing of this briefing were discussed.</p> <p><b>Action: The LGRG members to send any information to the NICE team which might be of use with this briefing.</b></p>	<p><b>LGRG</b></p>
