Royal College of Nursing	No	<p>We are pleased that the guidelines cover Looked after children in care.</p> <p>We however, consider that the guidelines should address the following:</p> <p>1) Foetal Alcohol Spectrum Disorder (FASD): Children who may have a diagnosed or undiagnosed condition of foetal alcohol spectrum deficit should be specifically flagged.</p> <p>2) STOMP LD - NHS Guidance which covers the 'Stopping over medication with people with Learning Disabilities' should be cited as key work. In essence, too many are over prescribed psychotropic medication without seeking alternative therapeutic interventions. We would suggest nursing care should be an integral part of the alternative approaches.</p> <p>3) Liaison and diversion models now being seen across the country are of benefit to this group. Where nurses work closely with police there is an opportunity to evidence good practice of early intervention and diversion from prison.</p>	<p>Thank you for your comments. All the areas highlighted in the comments were included in the guideline. Current recommendations advise on conducting a comprehensive assessment for case identification and include assessment of alcohol use during pregnancy. Although children with coexisting learning disabilities are included within the scope of this guideline, other more relevant guidelines cover pharmacological treatments in detail for this population (see NICE guideline NG54 <a href="#">mental health problems in people with learning disabilities</a>).</p> <p>The search strategy for the surveillance evidence search was designed to identify evidence on foetal alcohol spectrum disorder, interventions for people with coexisting learning disabilities, populations in contact with the criminal justice system and restrictive practices. However, no evidence was found in the surveillance review relating to these areas therefore no impact on the guideline was determined at this time. We have noted your comments and these areas will be considered again at the next surveillance review of NICE guideline CG158.</p>
