1. Welcome, declarations of interest and minutes review

2. Health economics queries for cardiovascular outcome trial (CVOT) review

The Chair introduced Technical Adviser, Health Economics, Lucy Beggs (LB), and Technical Analysts, Health Economics, Thomas Jones (TJ) and Kusal Lokuge (KL), who presented the committee with some health economic queries in relation to the CVOT review.

3. CVOT clinical review queries

The Chair introduced Technical Analyst Gregory Moran (GM), who gave a clinical overview of the CVOT review and asked the committee for input on specific questions relating to the data used and the trials for inclusion in the CVOT review protocol.

4. CKD review overview and questions

The Chair introduced Technical Adviser Kathryn Hopkins (KH), who gave an overview of the review protocol for the effectiveness of SGLT2 inhibitors for people with chronic kidney disease and type 2 diabetes for the NICE draft guideline on chronic kidney disease.

Technical Adviser, Health Economics, Lucy Beggs (LB) then posed some health economics queries to the committee in relation to the CKD guideline update.

The Chair thanked Kathryn and Lucy for their presentations and the committee for their feedback.
